

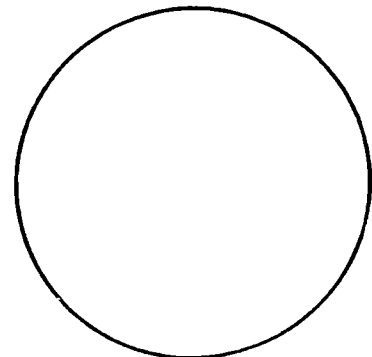



AND TESTAMENT of me

ELSIE DOROTHY GLAZIER of 131 Hughenden Road Hastings in the  
County of East Sussex Widow

1. I HEREBY REVOKE all former Wills and testamentary dispositions heretofore made by me
2. I DESIRE that my body be cremated and my ashes scattered in the Garden of Remembrance of the Crematorium situate nearest to the place of my residence at the date of my death
3. I APPOINT my Niece DORA CHANDLER of 48A Wickham Avenue Bexhill-on-Sea in the County of East Sussex Spinster (hereinafter called "my Trustee") to be the SOLE EXECUTRIX AND TRUSTEE of this my Will
4. I GIVE AND BEQUEATH free of Capital Transfer Tax and other fiscal impositions the following specific and pecuniary legacies :
  - (a) My late Husband's ring to GEOFFREY GLAZIER of 20 Birchwood Avenue Wallington Surrey
  - (b) My rings to my said Niece DORA CHANDLER and the sum of TWO HUNDRED POUNDS
  - (c) My Carriage Clock to MRS. JOYCE BURT of 4 Elm Walk Hastings aforesaid
  - (d) To MRS. EVANGELINE BURCHELL of 371 Priory Road Hastings aforesaid the sum of TWO HUNDRED POUNDS
  - (e) To the Trustees for the time being of the HASTINGS MUSICAL FESTIVAL the sum of ONE HUNDRED POUNDS for the general purposes of the Festival
  - (f) To the Officer in Charge for the time being of the HASTINGS SALVATION ARMY CITADEL YOUNG PEOPLE'S BAND for the general purposes of the said Band the sum of TWO HUNDRED POUNDS
  - (g) To MISS BRENDA GLAZIER of 7 Cavendish Avenue St. Leonards-on-Sea East Sussex the sum of ONE HUNDRED POUNDS
  - (h) To LINDENS OLD PEOPLE'S HOME of Upper Maze Hill St. Leonards-on-Sea aforesaid the sum of TWO HUNDRED POUNDS for the general purposes of the said Home
5. I GIVE DEVISE AND BEQUEATH all the remainder of my estate both real and personal whatsoever and wheresoever situate unto my Trustee UPON TRUST to sell call in and convert the same into money with power in her absolute discretion to postpone any such

sale calling in and conversion for so long as she may deem necessary without being liable for loss and to stand possessed of the net proceeds and my ready moneys upon the following trusts that is to say :-

- (a) To pay thereout my just debts funeral and testamentary expenses \_\_\_\_\_
- (b) To divide the remainder into three equal parts or shares
- (c) To pay one of such equal parts or shares to THE LEAGUE OF FRIENDS OF THE ROYAL EAST SUSSEX HOSPITAL Cambridge Road Hastings aforesaid for its general purposes \_\_\_\_\_
- (d) To pay the second of such equal parts or shares to THE LEAGUE OF FRIENDS OF THE MALMESBURY HOUSE CHILDREN'S HOME West Hill Road St. Leonards-on-Sea aforesaid for its general purposes \_\_\_\_\_
- (e) To pay the third of such equal parts or shares to the BRITISH EMPIRE CANCER CAMPAIGN FOR RESEARCH whose Registered Office is at 2 Carlton House Terrace London SW1Y 5AR for its general purposes \_\_\_\_\_

6. I DIRECT that the receipt of the Treasurer or other proper officer of the said Leagues of Friends and Campaign shall be a good and sufficient discharge for my Trustee \_\_\_\_\_
